This allows the program to identify any discrepancies allowing us to proactively address them before fully transitioning into Workday. Unlocking Efficiency: A Deep Dive into Workday's Supplier Invoice Request Process

In Workday, when seeking a payment for goods or services without an existing purchase order, such as subscriptions or membership dues, users initiate a Supplier Invoice Request. This process streamlines the submission of invoices not on purchase orders that are sent directly to departments by suppliers for payment to central Accounts Payable. The request captures essential details like the supplier's name, invoice date, and invoice information. Before initiating a request, the supplier must be established in Workday. This responsibility will be assigned to individuals with specific security roles ensuring an efficient, controlled, and secure process for creating suppliers in the Workday system.
